WELCOME

The Te Whakarōputanga Kaitiaki Kura o Aotearoa Services Catalogue 2024 has been prepared for boards in the compulsory state and state integrated school sector. The catalogue lists the wide range of services available to boards and their principals from Te Whakarōputanga Kaitiaki Kura o Aotearoa under our arrangement with the Ministry of Education – Te Tāhuhu Mātauranga.

The services we offer are to help boards meet their legal obligations and be good governors of their schools. We have also developed a series of services to help principals fulfil their role as the board's chief executive of the school.

Under the Education and Training Act 2020, school boards are a crown entity with significant authority and responsibilities. Whilst Te Whakarōputanga Kaitiaki Kura o Aotearoa will provide support and guidance on best practice we cannot direct a board on how it should exercise its authority or what decision it should make. Our role is to help the board make an informed decision. Similarly, our advice for principals is to help guide, them to fulfil their role based on the delegated authorities they have received from the board. The decisions a principal makes in respect of their operational duties is their responsibility.

Our services are delivered through our Advisory & Support Centre, Regional Advisory team and the Te Whakarōputanga Kaitiaki Kura o Aotearoa Resource Centre. The Advisory and Support Centre are our frontline team, you can contact them by calling our 0800 number or by email. On taking your call or receiving your email, your enquiry is directed to an ASC governance or employment advisor. Our ASC advisor will look to resolve your enquiry at point of contact or within 2 business days. However, if your matter requires ongoing support, you will be referred to a regional governance or employment advisor. As their name suggests our regional advisors are based within proximity to your school and will work with you to agree on next steps and clarify the support we can provide.

The Te Whakarōputanga Kaitiaki Kura o Aotearoa Resource Centre is our online information, and resource knowledge base. The resource centre has guidance prepared specifically for boards (Help for Boards) and principals (Help for Principals). You will also find under “Learning Events and Online Courses” the full array of resources, live workshops and online events to support your professional learning and development as a board member.

Boards and their principals operate in a dynamic and at times complex environment – you have our commitment that upon request we will be there to support and guide you within the scope of the services set out in this catalogue.
